Technical Data sheet - Empty Fruit Bunch (EFB)

Empty fruit bunch fibre is a non-hazardous, biodegradable material that is produced from empty fruit bunches. It is considered as waste after the extraction oil palm fruits. The fibres are clean, noncarcinogenic, and free from pesticides and soft parenchyma cells. Palm fibres are versatile and stable. They can be processed into various dimensional grades to suit specific applications such as erosion control, mattress cushion production, soil stabilization, horticulture and landscaping, ceramic and brick manufacturing, paper production, to name but a few of its uses.
